- General Description of Services: The Tucson Airport Authority (TAA) is seeking a qualified design professional firm who is licensed and registered to practice architecture in the State of Arizona to provide investigation, design, estimating, construction documents and construction administration for the residential sound insulation of approximately 48 Housing Units near Tucson International Airport. The Design Professional shall be responsible for homeowner coordination, conducting field verification of each housing unit/structure to confirm the final number and types of housing units. The Design Professional shall work with the City of Tucson and TAA to gather previous sound insulation project information to remove housing units which were previously sound insulated by TAA. The Design Professional or Subconsultant assigned by the Design Professional shall work with the City of Tucson to secure and pay for all permits associated with this work. The Design Professional shall work with a title company to assure the TAA Avigation Easement is recorded by each property owner for all residences where this project work occurs. Agreement will be subject to available funding from the Federal Aviation Administration (FAA) and the Arizona Department of Transportation (ADOT) and will be issued as a multi-year contract. RFQ statements will be accepted from any architectural firm and joint venture registered to practice in the State of Arizona and qualified to provide the necessary services.
- 4. <u>General Description of Project</u>: The successful firm will be required to provide design professional services to complete the project including: field investigation (home preview), schematic design services, environmental testing, noise measuring of sound levels (before/after construction), preparation of construction documents, and basic construction administration services.

- 7. <u>Date and Time for Submission of SOQ</u>: Written SOQs will be received by TAA until 2:00p.m. Local Tucson Time on Tuesday, March 3, 2020, attention Debbie Cruz, Procurement Administrator at the TAA Administration Offices, Tucson International Airport, Third Floor, 7250 South Tucson Boulevard, Suite 300, Tucson, Arizona 85756. One (1) original and 5 copies of the SOQ are required to be addressed and delivered to TAA on or before the day and hour set for receipt. An SOQ may be withdrawn by written request any time

before the scheduled time and date for receipt. Any SOQ submitted after the designated date and time will not be accepted or considered.

- 8. <u>Pre-Submission Conference</u>: A pre-submission conference for the project will be held on Friday, February 14, 2020, at 10:00 a.m., at the TAA Administrative Offices, 7250 S. Tucson Blvd., Catalina Room, 3rd Floor, Tucson, Arizona 85756. At this conference, TAA staff will discuss the scope of services, the proposed date for interviews, the selection process, and respond to questions about the RFQ. The presubmission conference will also include an opportunity to visit the sites of the proposed services.
- 9. <u>No Prices or Pricing Information</u>: SOQs submitted by any interested persons or firms shall **NOT** include prices or any pricing information for the proposed services.
- 10. <u>Costs of Responding to the RFQ</u>: Any and all costs associated with responding to this RFQ or providing an SOQ shall be borne solely by the interested person or firm.
- 11. <u>TAA's Right to Reject for Any Reason</u>: TAA reserves the right to reject any or all SOQs, any other proposals or submissions, to cancel the RFQ, or to withhold the award of any contract relating to the RFQ for any reason which TAA determines.
- 12. <u>Interest List</u>: TAA maintains an interest list consisting of all design professionals, contractors, subcontractors/subconsultants, and major suppliers who have bid on airport projects. Each firm must complete and submit, with its submittal, information with respect to such firm in the form included in the solicitation documents. The listing of a firm on any TAA interest list is not an endorsement of that firm and does not indicate that the firm has been pre-qualified for airport work.
- 13. <u>Civil Rights Title VI Solicitation Notice.</u> The Tucson Airport Authority, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.
- 14. <u>DBE</u>: It is the policy of the Department of Transportation ("DOT") and TAA that Disadvantaged Business Enterprise firms ("DBEs") as defined in 49 CFR Part 26 (the "DBE Regulations"), shall have a fair and equal opportunity to participate in the performance of contracts financed in whole or in part with federal funds. TAA, in compliance with 49 CFR § 26, has adopted a program regarding the participation of DBEs on federally funded projects. TAA has set an aspirational 7% (7% of the dollar value of the contract) DBE participation goal for this contract. Specifically, it is the goal of TAA to ensure that, to the extent reasonably possible and consistent with other legal requirements that: (a) DBEs are not discriminated against in the award and administration of TAA's contracts; (b) a level playing field is created on which DBEs can compete fairly for TAA's contracts; and (c) any barriers to the participation of DBEs in TAA's contracts are removed.
- 15. <u>Legal Requirements</u>: The services to be performed will be subject to the provisions of Title 34 of the Arizona Revised Statutes (A.R.S. § 34-101, *et seq.*, as amended). All persons or firms submitting an SOQ and their subconsultants must be duly licensed to perform the work at the time the SOQ is submitted (or exempt from licensing requirements) pursuant to all applicable laws, rules, and regulations. If a licensing exemption is claimed, the person or firm must set forth the basis for the claimed exemption in writing at the time the SOQ is submitted. In addition, the proposed project will be paid for in part with monies to be received from FAA and ADOT. For grant funded projects, additional terms and conditions may apply as set forth in the RFQ and proposed Contract Documents.

Federal Requirements. Any person or firm submitting an SOQ in response to this RFQ must certify compliance with the trade restriction requirements set forth in 49 CFR Part 30, and will be required to comply with the requirements in any resulting contract. Any person or firm submitting an SOQ in response to this RFQ must certify compliance with the prohibitions on federal lobbying found in Appendix A of 49 CFR Part 20.

The successful Respondent to this RFQ will be required to assist TAA to ensure compliance with multiple federal requirements, including, but not limited to, those found in Section 6002 of the Solid Waste Disposal Act, as amended, and the regulatory provisions of 40 CFR Part 247.
