- 4. <u>Nature, Type, and Purpose of Work</u>: Aeronautical Way is a 3,000 linear foot service road that serves aeronautical development east of the Tucson International Airport along Alvernon Way. Aeronautical Way requires improvement to anticipate potential development and increased traffic capacity in this area.
- 5. <u>Description of Work</u>: The project comprises of construction improvements to Aeronautical Way providing approximately a 1,000-foot paved roadway extension with two through lanes, an end cul-de-sac for turnaround, painted center turn lane for future connecting roadways. Construction improvements to the Alvernon Way/Aeronautical Way intersection to provide newly paved through lanes and turn lanes along Alvernon Way. Also, through lanes with a left and right turn along Aeronautical Way. Major elements associated with this project include construction and installation of airside earthen road grading, asphaltic concrete paving, curb and gutter, scuppers; storm drain culverts, security fencing, signage, and pavement markings.

- 7. <u>Submission of Bids</u>: The Tucson Airport Authority ("TAA") invites interested contractors to submit sealed bids for 10123529 Alvernon Way/Aeronautical Parkway Construction. Sealed bids will be received until 2:00 p.m. Local Tucson Time, Wednesday May 22, 2024 at the TAA Administration Building, 7250 S. Tucson Boulevard, Suite 300, Tucson, AZ 85756 in accordance with the requirements of the Bid Documents. Bids will then be publicly

opened and read aloud. Bids received after the time designated for opening will not be considered.

- 8. <u>Copies of Drawings and Specifications</u>: Contractors desiring to submit bids may obtain copies of full or partial sets of drawings and specifications for estimate on request or by appointment. The return of such drawings and specifications shall be guaranteed by a deposit of \$450.00 which shall be refunded on return of the drawings and specifications in good order. Copies of the drawings and specifications are on file and are open for public inspection at the TAA Administration Building, 7250 S. Tucson Boulevard, Suite 300, Tucson, AZ 85756. Copies of the Bid Documents may be obtained from Reproductions, Inc., 234E. 6th Street, Tucson, AZ 85705, 520-355-4902 for the required deposit of \$450.00. Checks must be made payable to Dibble Engineering.
- 9. <u>Pre-Bid Conference</u>: A pre-bid conference will be held at 10:00 a.m. Local Tucson Time, Tuesday May 7, 2024 in the Catalina Room of the TAA Administration Building, 7250 S. Tucson Boulevard, Suite 300, Tucson, AZ 85756. During the pre-bid conference, Bidders may inspect the site and Bidders' questions will be answered.
- 10. <u>Substantial Completion</u>: The successful Bidder who contracts with the TAA for the project will be required to achieve Substantial Completion of the entire Work in accordance with the terms of the parties' contract not later than <u>182 Days to Substantial Completion</u> Calendar Days after the issuance of the Notice to Proceed by the TAA.
- Bid Bond: Each Bid shall be accompanied by a certified check, cashier's check or surety bond ("Bid Bond") for ten per cent (10%) of the amount of the Base Bid and all Bid Alternates included in the Bid as a guarantee that the Bidder will enter into a contract to perform the proposal in accordance with the Drawings and Specifications. Notwithstanding the provisions of any other statute, the Bid Bond shall be executed solely by a surety company or companies holding a certificate of authority to transact surety business in Arizona issued by the Director of the Arizona Department of Insurance pursuant to Title 20, Chapter 2, Article 1 of the Arizona Revised Statutes. The Bid Bond shall not be executed by an individual surety or sureties, even if the requirements of Section 7-101 are satisfied. The certified check, cashier's check or Bid Bond shall be returned to the Bidders whose proposals are not accepted, and to the successful Bidder upon the execution of a satisfactory bond and contract as provided in Title 34 of the Arizona Revised Statutes. The conditions and provisions of the Bid Bond regarding the surety's obligations shall follow the following form: "Now, therefore, if the obligee accepts the proposal of the principal and the principal enters into a contract with the obligee in accordance with the terms of the proposal and gives the bonds and certificates of insurance as specified in the standard specifications with good and sufficient surety for the faithful performance of the contract and for the prompt payment of labor and materials furnished in the prosecution of the contract, or in the event of the failure of the principal to enter into the contract and give the bonds and certificates of insurance, if the principal pays to the obligee the difference not to exceed the penalty of the bond between the amount specified in the proposal and such larger amount for which the obligee may in good faith contract with another party to perform the

work covered by the proposal then this obligation is void. Otherwise, it remains in full force and effect provided, however, that this bond is executed pursuant to the provisions of Section 34-201, Arizona Revised Statutes, and all liabilities on this bond shall be determined in accordance with the provisions of the section to the extent as if it were copied at length herein."

- 12. <u>Costs of Responding to the Invitation to Bid</u>: Any and all costs associated with responding to this Invitation to Bid or in providing a Bid shall be borne by solely by the interested person or firm.
- 13. <u>TAA's Right to Reject for Any Reason</u>: TAA reserves the right to reject any or all bids or proposals or to withhold the award for any reason which TAA determines.
- 14. <u>Interest List</u>: TAA maintains an interest list consisting of all design professionals, contractors, subcontractors/subconsultants, and major suppliers who have bid on airport projects. Each firm must complete and submit, with its submittal, information with respect to such firm in the form included in the solicitation documents. The listing of a firm on any TAA interest list is not an endorsement of that firm and does not indicate that the firm has been prequalified for airport work.
- 15. <u>DBE</u>: It is the policy of TAA to ensure that Disadvantaged Business Enterprise firms ("DBEs") have a fair and equal opportunity to participate in TAA's contracts. Specifically, it is the goal of TAA to ensure that, to the extent reasonably possible and consistent with other legal requirements that: (a) DBEs are not discriminated against in the award and administration of TAA's contracts; (b) a level playing field is created on which DBEs can compete fairly for TAA's contracts; and (c) any barriers to the participation of DBEs in TAA's contracts are removed. If a bidder or subconsultant of the bidder are certified as DBE, the work performed by both shall be counted towards meeting the aspirational goal. Any work performed by a non-DBE bidder or subcontractor shall not. TAA has set an aspirational 7% (7% of the dollar value of the contract) DBE participation goal for this contract. As a matter of responsiveness, firms must complete and submit the "Statement of Proposed DBE Utilization" form in the form provided, with its submittal. Firms and firms' subcontractor/subconsultant who are submitting as DBEs must be certified DBEs in Arizona in good standing prior to the date submittals are due. TAA recognizes current DBE certifications by the ADOT, City of Phoenix, and City of Tucson. - 16. <u>Legal Requirements</u>: The Work to be performed will be subject to the provisions of Title 34 of the Arizona Revised Statutes (A.R.S. § 34 201, et seq., as amended). All Bidders and their subcontractors must be duly licensed to perform the work at the time the bid is submitted (or exempt from licensing requirements) pursuant to all applicable laws, rules and regulations. If a licensing exemption is claimed, the Bidder must set forth the basis for the claimed exemption in writing at the time the bid is submitted. In addition, the proposed project will be paid in part with monies to be received from. For grant-funded projects, additional legal

requirements may be required as set forth in the Bid Documents and proposed contract documents.
