4. <u>Nature, Type, and Purpose of Work</u>: Tucson International Airport (TUS) serves commercial, cargo, general aviation, and military activity operations. TUS also supports Fixed Based Operators (FBO), aircraft maintenance and repair facilities, private and leased hangars. Northwest of the Executive Terminal Building is an area referred to as General Aviation (GA) Area B-1 that consists of general aviation aircraft parking, tie-downs, and shade structure, along with nested box hangars (T-hangars). The pavement in this area has reached it useful life and is severely cracked and weathered. There is evidence of subgrade failure beneath the pavement surface. The pavement section in this area will require rehabilitation and full reconstruction. Associated with this project is to reconstruct roadway pavement to the entry/exit of GA Area B-1.

5. <u>Description of Work</u>: Major elements of work include the following: Demolition and removal of existing pavements, excavating existing base course and native soils to a depth that matches the new pavement thickness, and placing new base course and asphalt pavement. Mill and Overlay at pavement around T-Hangars B-16 and B-18. Construction of two-foot wide concrete ribbon curb around T-Hangars. Installation of new aircraft tie-down anchors and new pavement markings applied.

10. <u>Substantial Completion</u>: The successful Bidder who contracts with the TAA for the project will be required to achieve Substantial Completion of the Base Project in accordance with the terms of the parties' contract not later than 45 Calendar Days after the issuance of the Notice to Proceed by the TAA.

Bid Bond: Each Bid shall be accompanied by a certified check, cashier's check or 11. surety bond ("Bid Bond") for ten per cent (10%) of the amount of the Base Bid and all Bid Alternates included in the Bid as a guarantee that the Bidder will enter into a contract to perform the proposal in accordance with the Drawings and Specifications. Notwithstanding the provisions of any other statute, the Bid Bond shall be executed solely by a surety company or companies holding a certificate of authority to transact surety business in Arizona issued by the Director of the Arizona Department of Insurance pursuant to Title 20, Chapter 2, Article 1 of the Arizona Revised Statutes. The Bid Bond shall not be executed by an individual surety or sureties, even if the requirements of Section 7-101 are satisfied. The certified check, cashier's check or Bid Bond shall be returned to the Bidders whose proposals are not accepted, and to the successful Bidder upon the execution of a satisfactory bond and contract as provided in Title 34 of the Arizona Revised Statutes. The conditions and provisions of the Bid Bond regarding the surety's obligations shall follow the following form: "Now, therefore, if the obligee accepts the proposal of the principal and the principal enters into a contract with the obligee in accordance with the terms of the proposal and gives the bonds and certificates of insurance as specified in the standard specifications with good and sufficient surety for the faithful performance of the contract and for the prompt payment of labor and materials furnished in the prosecution of the contract, or in the event of the failure of the principal to enter into the contract and give the bonds and certificates of insurance, if the principal pays to the obligee the difference not to exceed the penalty of the bond between the amount specified in the proposal and such larger amount for which the obligee may in good faith contract with another party to perform the work covered by the proposal then this obligation is void. Otherwise it remains in full force and effect provided, however, that this bond is executed pursuant to the provisions of Section 34-201, Arizona Revised Statutes, and all liabilities on this bond shall be determined in accordance with the provisions of the section to the extent as if it were copied at length herein."

12. <u>Costs of Responding to the Invitation to Bid</u>: Any and all costs associated with responding to this Invitation to Bid or in providing a Bid shall be borne by solely by the interested person or firm.

13. <u>TAA's Right to Reject for Any Reason</u>: TAA reserves the right to reject any or all bids or proposals or to withhold the award for any reason which TAA determines.

14. <u>Interest List</u>: TAA is compiling an interest list consisting of all contractors, subcontractors, and major suppliers who have bid on airport projects. If the contractor, or any subcontractor or major supplier, from which the contractor is soliciting a bid is not on TAA's interest list, the contractor must complete and submit, with its bid, information with respect to such person or firm in the form included with the Instructions to Bidders.
