CHANGES TO DOCUMENT

Proposals are due by 2:00 p.m. Local Tucson Time on Wednesday, May 28, 2025, addressed to Sara Perry, Procurement Administrator, Tucson Airport Authority, 7250 S Tucson Blvd Ste 300, Tucson, AZ 85756.

RESPONSES TO QUESTIONS

Q1: In document 10322466 Airport Management System Modules – Addendum #2 provided by TUS, it is stated that TUS will notify the shortlisted firm on Wednesday, June 4, 2025. However, the document also mentions that TAA intends to award the contract on Wednesday, June 4, 2025. Could you please clarify the timeline?

Answer: We intend to notify shortlisted firms by June 11, 2025. We intend to award the contract by the end of July.

Q2: Please list all the integrations TAA is seeking with this system. Please specify all internal or external system integrations that will be needed for this project.

Answer: Proposers must include all known integrations and API's available with your solution for TAA to evaluate priced separately or included in your base bid. The list below is not comprehensive of all the possible integrations since we don't know what each vendor offers.



Potential integrations included in your base bid, may include: Oracle EBS, M365, ESRI ArcGIS. Please include REST or open API with put, get, post, and other options.

Q3: Are you looking to award multiple companies for different parts of the RFP and should we submit a proposal addressing only the flight tracking requirement?

Answer: We would like to have one single solution provider.

Q4: Please confirm that the Price Sheet in Attachment 3 can be expanded to include the requested "software itemized per module", detailed points of integration and other relevant details.

Answer: Yes, this is acceptable.

Q5: Would TAA consider a two-week extension of the deadline, given that the current Q&A deadline only gives proposers a maximum of three business days to incorporate any new information from the question and answer period before having to mail hard copies of their proposals to the Authority?

Answer: We will allow a one-week extension.

Q6: We respectfully request that TAA allow all respondents to submit their proposals digitally and waive the requirement for mailing a physical copy. Alternatively, we request a one-week extension of the submission deadline, to May 28, 2025, to allow adequate time for preparation and delivery.

Answer: TAA will accept a pdf submission emailed to Sara Perry, sperry@flytucson.com, no later than 2:00 p.m. Local Tucson Time, on May 28, 2025. TAA still expects a physical Proposal (one original and five copies) submitted no later than 2:00 p.m. Local Tucson Time, on May 28, 2025.
