Local Board Attorney Apodaca asked to clarify whether the motion included giving the Local Board Secretary the authority to send the 30-day notice letter pursuant to § D, PSPRS Model Rules. Board Member Lackey concurred.

Acting Chair Villicaña stated that the 30-day notice letter is addressed in the procedures the Board adopted in Item 5.b. This administrative action is automatically triggered by the Board's vote on the pre-existing condition. Apodaca concurred.

As this matter was previously tabled, the consensus of the Board was for the Local Board Attorney to attempt to obtain a pre-existing condition determination from an out-of-state physician. If that method is unsuccessful, staff will explore having a local physician complete the pre-existing condition cover sheet during Firefighter Daw's annual physical. As Daw is halfway through year one, his annual physical is due in approximately five-to-six months.
