1. CALL TO ORDER | ROLL CALL

Chair Ronstadt called the meeting to order at 8:04 a.m.

2. APPROVAL OF MINUTES

Motion by Vice Chair Villicaña, seconded by Board Member Ivanoff, to approve the minutes of the PSPRS Local Board meeting held on October 17, 2023. The motion carried by the following vote:

3. JEFFREY STREBING DISABILITY APPLICATION

Motion by Board Member Ivanoff, seconded by Vice Chair Villicaña, to recess the public meeting and convene in executive session to discuss and to receive legal advice from the Board attorney regarding the disability application filed by former TAA employee Jeffrey Strebing. The motion carried by the following vote:

Chair Ronstadt recessed the public meeting, and the Board went into executive session at 8:08 a.m.

The executive session adjourned, and Chair Ronstadt reconvened the public meeting at 8:31 a.m.

Chair Ronstadt invited Mr. Jeffrey Strebing and his attorney, Tom Stillwell, to make any final comments before the Board voted on the disability application.

Mr. Strebing, under questioning from Mr. Stillwell, relayed the following:

- 1) In December 2020, Mr. Strebing returned to TAA from active-duty military service and was undergoing reorientation training with his supervisor. During the week of training, which occurred during the early part of the COVID-19 pandemic, Mr. Strebing and the supervisor were frequently in close contact in the office and on vehicle patrols.
- 2) After two days, the supervisor called out sick and subsequently received a positive test for COVID-19. Approximately one-to-two days later, Mr. Strebing also developed symptoms and tested positive for COVID-19. Mr. Strebing's recovery took approximately four-to-five weeks.
- 3) Mr. Strebing returned to TAA in January 2021 and worked until April 2021. He stated that he felt weak most of the time and his mental health was suffering. His condition caused him to make mistakes and to forget information. Furthermore, he was not getting enough sleep, and his sleeping patterns became irregular. Mr. Strebing had a "breakdown" in April 2021 and subsequently requested help from the human resources department.
- 4) Mr. Strebing stated that he did not suffer from "brain fog," stuttering, or anxiety prior to his exposure to COVID-19. His stuttering became worse over time, prompting him to seek help from the Veterans Administration (the VA). His stuttering has improved though it worsens when he suffers from anxiety.
- 5) His condition causes him to isolate from people to avoid confrontations. When confronted with a situation, he tries to walk away and use breathing techniques and other therapies to control his stress. He cries more often.
- 6) Mr. Strebing and Mr. Stillwell disagreed with the finding of the Independent Medical Examiners that his condition is neither permanent nor uncorrectable. Mr. Strebing sought mental health treatment from a private doctor; however, due to the doctor's retirement, Mr. Strebing was forced to turn to the VA for mental health treatment.

Because the VA is overwhelmed, Mr. Strebing sees a physician fewer times than before. Furthermore, the VA only covers a certain number of speech therapy sessions, and they discharged him once they believed he had improved “enough.”

- 7) Mr. Strebing is still trying to overcome his sleep issues. He has been diagnosed with sleep apnea, but he is unable to wear the CPAP mask due to claustrophobia.
- 8) Mr. Strebing and Mr. Stillwell claimed that the Independent Medical Examiners did not have enough information regarding the long-term effects of COVID-19 to determine whether his conditions are temporary or permanent.

Mr. Stillwell pointed out that there is case law establishing that accidents may include contracted diseases and their affects. He stated that he had litigated and established that COVID-19 is a work-related “accident” as defined by Workers Compensation and his belief that it is also covered under the PSPRS statutes. Mr. Stillwell objected to Dr. Kirkorsky’s report because he specializes in Worker’s Compensation cases and does not have a special background or focus treating long COVID-19. The doctor’s conclusions were vague, and the Board should not place great weight on his opinion.

BOARD DISCUSSION

The Board members stated their conclusions based on the records provided by the claimant, Jeffrey Strebing, the Independent Medical Examiners, and the Board’s attorney. The Board’s consensus was the following:

- 1) There were inconsistencies and “untruths” between the records provided by the Veterans Administration and the reports provided by the Independent Medical Examiners in the companion Workers Compensation claim.
- 2) There was no concrete evidence that Mr. Strebing contracted COVID-19 from workplace exposure.
- 3) Regarding conflicting opinions of the two IME specialists the Board did not feel the conflicts were of a nature that they had to side with one opinion or the other.

Motion by Vice Chair Villicaña, seconded by Board Member Lackey, to deny the application for accidental disability filed by Jeffrey Strebing based on the following findings:

- 1) **While there are differences of opinion between Dr. Scott E. Kirkorsky’s October 12, 2023 report and Dr. Shannah Biggan’s October 20, 2023 report they both agree that Mr. Strebing’s condition is not permanently disabling (Biggan at pp. 12-13; Kirkorsky at p. 30).**

- 2) Neither provider finds that Mr. Strebing qualifies for Ordinary Disability, with Dr. Kirkorsky specifically finding that there is no evidence of permanency or Mr. Strebing’s inability to find any gainful employment, (p. 31) and Dr. Biggan specifically finding a lack of permanency (p. 12-13).
- 3) Dr. Kirkorsky notes that there are conflicts in medical evidence in his questionnaire responses; however, his report does not describe the kinds of medical conflicts that would require Board review.

The motion carried by the following vote:
