Re: 2024 Board Meeting Dates/Meeting Format

Background:

The PSPRS Joint Fire and Police Local Board is required to meet a minimum of two times per year pursuant to A.R.S. § 38-847(C), although the Board has historically scheduled meetings on the third Tuesday of the first month of each quarter beginning at 8:00 a.m. The Board's consensus at the time it approved the 2023 meeting schedule was to continue holding quarterly meetings until the backlog of Pre-Existing Condition determinations had been caught up. The backlog is anticipated to be eliminated no later than the first board meeting of 2024. If the Board desires to continue the current schedule, the meeting dates for 2024 will be as follows:

First Quarter: Tuesday, January 16, 2024

Second Quarter: Tuesday, April 16, 2024

Third Quarter: Tuesday, July 16, 2024

Fourth Quarter: Tuesday, October 15, 2024

The Board has also held completely virtual meetings as a precaution during the COVID-19 pandemic. The Board has the discretion to continue meeting virtually, move back to in-person meetings, or a hybrid of the two.

Recommendation:

Adopt a consensus as to the frequency, start time, and format of meetings for 2024 and direct Board staff to take the necessary steps to schedule the meetings in compliance with the Arizona Open Meeting Law.
