3. PRESIDENT/CEO REPORT

State of the Industry | Update

President/CEO Danette Bewley reported the following:

☐ The Federal Aviation Administration (FAA) Five-Year Reauthorization bill was passed by the United States Congress and signed into law by President Joseph



R. Biden. The legislation includes additional set-aside funding for runway safety projects, with an overall increase for infrastructure projects from \$3.5B to \$4B.

TUS is experiencing a strong 12% growth year over year. The United States Department of Transportation recently rated TUS as the fourth highest growing airport of the top 75 airports in the nation. TAA projects that the airport will see 4M enplaned and deplaned passengers, which is a significant milestone.
