3. PRESIDENT/CEO REPORT

State of the Industry | Update

President/CEO Danette Bewley reported the following:

- Airline CEOs are meeting with Kelly Ortberg, the new CEO of Boeing. They are expressing optimism that Mr. Ortberg will implement changes to improve the safety and reliability of their aircraft. The airlines have suffered huge losses during the past two years due to the grounding of large portions of their fleets after several high-profile incidents and accidents. The Federal Aviation Administration (FAA) has capped their

production to 38 per month, which presents challenges to the industry as the Boeing 737 is the world's most popular aircraft.

- ❑ Tucson continues to remain an attractive market to the airlines. Projections are for a 12% increase in capacity over the next several months.
- ❑ TUS secured a \$55M grant from the FAA for the Airfield Safety Enhancement (ASE) Program.

Council Member Piña joined the meeting at 11:06 a.m.

4. PRESENTATION/DISCUSSION

a. 2025 Nominating Period | Update:

TAA Clerk Byron Jones reported the following:

- ❑ Based on expiring terms and applications for emeritus status submitted by active Members, the Nominating Council had the opportunity to nominate up to eight new Members to TAA.
- ❑ Subsequent to the last council meeting, Council Member Stewart submitted a nomination packet on behalf of **Nancy Kluge**, President/CEO of the Reid Park Zoo. Three nomination packets had been received as of August 19, 2024.
- ❑ Five Members had submitted emeritus applications. The applications were included in the agenda packet.

The Council discussed nominating **Mimi Coomler, R.N.**, CEO of the Tucson Medical Center. Chair Lovallo stated that she would be meeting with Ms. Coomler later in the week and she would follow up on her interest in becoming a Member.

Council Member Stewart reported that she intends to submit nomination packets on behalf of **Linda Mazon Gutierrez**, Emeritus President and CEO of the Hispanic Women's Corporation and **Dr. Elliott Cheu**, Interim Senior Vice President of Research and Innovation at the University of Arizona.
