**OFF-AIRPORT PARKING LOT OPERATOR:**

Permits issued quarterly, with fees paid monthly pursuant to the terms of the Operating Agreement.

**OFF-AIRPORT CAR RENTAL COMPANIES:**

Fees paid monthly pursuant to the terms of the Operating Agreement.

**LUGGAGE DELIVERY SERVICE:**

Fees are \$60.68 per vehicle per month, and shall be paid in advance. Permits are issued on a monthly or quarterly basis.

**TRANSPORTATION NETWORK COMPANIES (TNC) aka APP RIDES**

Fees paid monthly pursuant to the terms of the Operating Agreement.

**COMMERCIAL GATE ARM CARD FEES:**

\$25.00 Flat fee to obtain a Card (original issue)	\$10.00 Forgotten Card Fee
\$15.00 Lost/Stolen Card Replacement	\$15.00 Card Reassignment Fee
