Governing Regulations – 49 CFR Part 23

- Condition for Receiving Federal Assistance Airport Improvement Program (AIP)
- Engineering, Planning, and Construction Activities Tucson International Airport (TUS) & Ryan Airfield (RYN)
- Subject to Title 49 CFR Part 23 Participation of DBEs in Airport Concessions



ACDBE Program Objectives

- The regulations require that the airport have a program in place that achieves the following objectives:
 - Ensure nondiscrimination in the award and administration of opportunities for concessions by airports receiving DOT financial assistance;
 - Create a level playing field on which ACDBEs can compete fairly for opportunities for concessions;
 - Ensure that the ACDBE program is narrowly tailored in accordance with applicable law;
 - Ensure that only firms that meet eligibility standards are permitted to participate as ACDBEs;
 - Help remove barriers to the participation of ACDBEs in opportunities for concessions at airports receiving DOT financial assistance; and
 - Provide appropriate flexibility to airports receiving DOT financial assistance in establishing and providing opportunities for ACDBEs.

- Goal of the AZUCP
 - Standardize the DBE/ACDBE certification policies, procedures and materials
 - Develop and implement database online publication
- Online Applications Arizona Unified Transportation Registration and Certification System (AZ UTRACS)

- Establish Overall Goal (Set Triennially)
- Certification Performed by AZUCP
- Contracting Activities
- Monitoring and Enforcement
- Reporting Performed Annually

Setting the overall goal for participation for Car Rental



Step 1: Examined Potential Goods and Services

Looked up NAICS Codes

Reviewed Certified Firm Directory

Pulled all Certified Firms Under NAICS Code Using 2021 County Business Patter NAICS Code

Comparison

Step 2: Pulled ACDBE Achievements for past 2 fiscal years

Adjustment: Calculate Step 1 and Step 2 Results

TAA's ACDBE Goal Setting Calculations Car Rental

Results



Step 1: Base Figure – 8.91% divided by 19 = 2.8% Average ACDBE Availability

Step 2: Arranging this historical data from low to high (8.98%, 13.28%, 28.77%), the median is 13.30%

Adjustment:

Base Figure for Certified Firms Availability = 2.8%

Historical Data for Participation = 13.30%

2.8% + 13.30% = 16.10%

Divided by 2

Proposed ACDBE Overall Aspirational Goal for FY 2025-2027 is 8%, to be accomplished through 0.0% Race Conscious and 8% Race Neutral Basis.

TAA's ACDBE Goal Setting Calculations Other Than Car Rental

Results



Step 1: Base Figure – 19.91% divided by 13 = 1.5% Average ACDBE Availability

Step 2: Arranging this historical data from low to high (17.3%, 17.4%, 17.8%), the median is 17.6%

Adjustment: Base Figure for Certified Firms Availability = 1.5%

Historical Data for Participation = 13.30%

1.5% + 17.6% = 19.1%

Divided by 2

Proposed ACDBE Overall Aspirational Goal for FY 2025-2027 is 9.55% rounded to 9.6%, to be accomplished through 0.0% Race Conscious and 9.6% Race Neutral Basis.
