

TUS Social Media 2020 Facemask Giveaway

Official Rules

By entering this TUS Social Media 2020 Facemask Giveaway (“Giveaway”), participants agree that they have read and agree to be bound by the terms and conditions set forth below (“Official Rules”). ENTER TO WIN

Participants may submit an answer to the Giveaway prompt on TAA’s Facebook timeline entry, Twitter post or Instagram post associated with the Giveaway, by commenting on the post or emailing an answer to marketing@flytucson.com from July 15th, 2020 to August 12th, 2020.

Participants must be at least 18 years old to enter the Giveaway. All entries must be posted or received by TAA before 11:59 pm, on August 4th, 2020 MDT to be eligible. Limit one entry per participant. Odds of winning will vary depending on the total number of entries received by TAA.
